The Committee's report examines the human rights implications of these reviews and surrounding events, as well as reflecting in a broader sense on the work remaining to be done in order to embed a "human rights culture" in this country. The Committee's findings include that, although there is no evidence of a need to amend or repeal the Act, public misunderstanding and unease will continue so long as senior ministers make unfounded assertions about the negative impact of the Act on the criminal justice system and seek to use it as a scapegoat for administrative failings in their departments. The Committee acknowledges that the DCA review makes a fair and balanced contribution to the debate and supports its proposal for more proactive work to debunk public myths about the Act and to highlight its positive impact, for example for the rights of the disabled.
